Spring 2024 Enrollment Report Executive Summary

The Spring 2024 Enrollment Report provides an overview of student enrollment at Washburn University and Washburn Institute of Technology (Washburn Tech) originating from the 20th day census snapshot.

Table 1 contains the combined, duplicated headcount, credit hour, FTE comparisons and summary demographic data between Spring 2023 and Spring 2024 for Washburn University and Washburn Tech.

Tables 2 and 3 contain headcount, credit hour, FTE comparisons and summary demographic data between Spring 2023 and Spring 2024 for Washburn University and Washburn Tech, respectively. Tables 4-7, and Charts 1-3 provide longitudinal trends documenting headcount, credit hour and FTE changes for Washburn University only.

Figures 1-4 of this Executive Summary document changes in Washburn University and Washburn Tech's enrollment and FTE, and Washburn University's headcount including and excluding high school students and FTE for the past ten years (2015-2024).

Washburn University/Washburn Tech Headcount and FTE (Figures 1-4, pages 2-4)

- Washburn University/Washburn Tech Spring enrollment headcount and FTE peaked in Spring 2019 and afterwards declined until Spring 2023 and Spring 2024 which both saw increases.
- Washburn University Spring enrollment headcount and FTE declined for nine years, with a slight increase in Spring 2017 FTE, and larger increases in Spring 2024 headcount and FTE.

Washburn University/Washburn Tech Enrollment Summary (Table 1, page 5)

- Headcount increased by 317 students (5.4%) from 5,837 in Spring 2023 to 6,154 in Spring 2024.
- Credit hours increased by 4,395 (6.7%) from 65,997 in Spring 2023 to 70,392 in Spring 2024.
- FTE increased by 287 (6.3%) from 4,525 in Spring 2023 to 4,812 in Spring 2024.

Washburn University Enrollment Summary (Table 2, page 6)

- Headcount increased by 270 students (5.6%) from 4,783 in Spring 2023 to 5,053 in Spring 2024.
- Credit hours increased by 3,927 (7.5%) from 52,479 in Spring 2023 to 56,406 in Spring 2024.
- FTE increased by 256 (7.1%) from 3,624 in Spring 2023 to 3,880 in Spring 2024.
- Degree-seeking student headcount increased from 4,211 in Spring 2023 to 4,451 in Spring 2024 (5.7%); non-degree seeking students increased 5.2% during the same period.

Washburn Tech Enrollment Summary (Table 3, page 7)

- Washburn Tech total headcount enrollment increased by 47 students between Spring 2023 and Spring 2024, a 4.5% increase.
- Washburn Tech credit hour production increased by 468 credit hours, a 3.5% increase.
- FTE increased by 3.5% as well, from 901 in Spring 2023 to 932 in Spring 2024.

Washburn University Headcount Enrollment Charts (page 8)

- Seniors comprise the largest proportion of enrollment by student classification (21.9%)
- The gap in full-time to part-time students has narrowed then widened over a five-year period.

Washburn University Undergraduate Enrollment by Student Type (Table 4, page 9)

- The first-time freshmen headcount increased from 75 in Spring 2023 to 103 in Spring 2024.
- Transfer students increased from 129 in Spring 2023 to 187 in Spring 2024.
- Combined, the new student total increased from 5.9% in Spring 2023 to 7.7% in Spring 2024.

Washburn University Headcount Enrollment and Student Credit Hours (Table 5, page 10)

- Full-time headcount increased 7.0% and part-time headcount increased 2.8% in Spring 2024.
- Total headcount and student credit hours have decreased year-to-year over a ten-year trend, except in Spring 2017 and Spring 2018 which each had a slight increase in student credit hours, and in Spring 2024 where full-time headcount and student credit hours both increased.

Washburn University Headcount by Gender (Table 6, page 11)

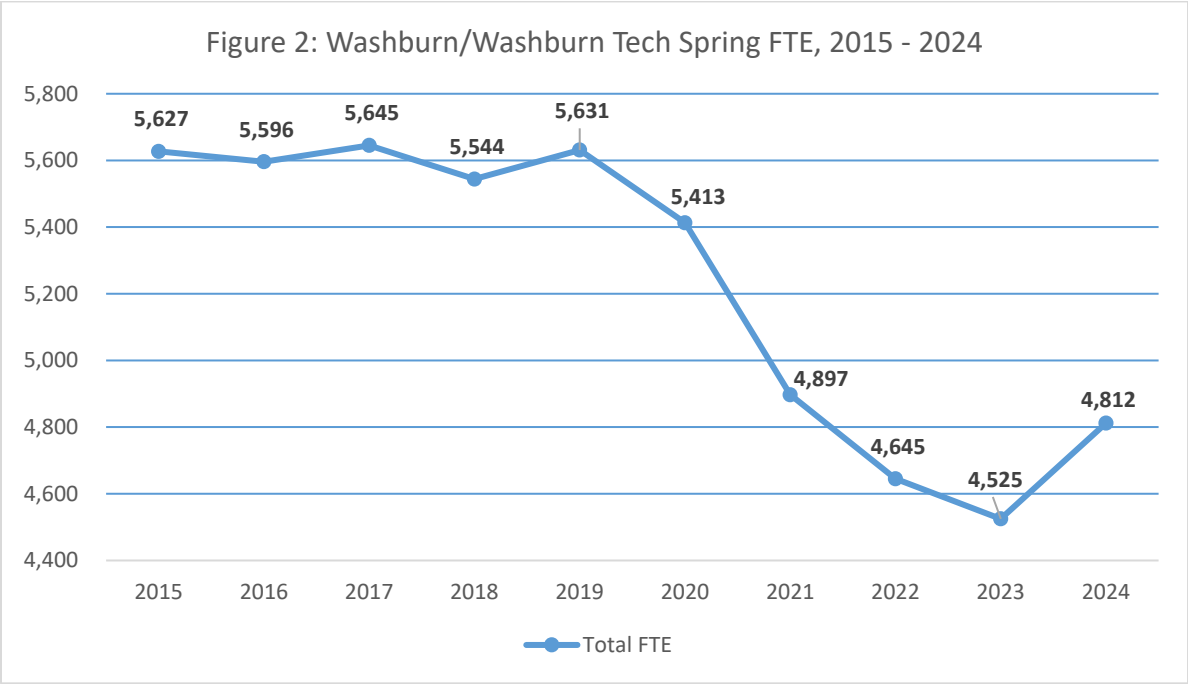
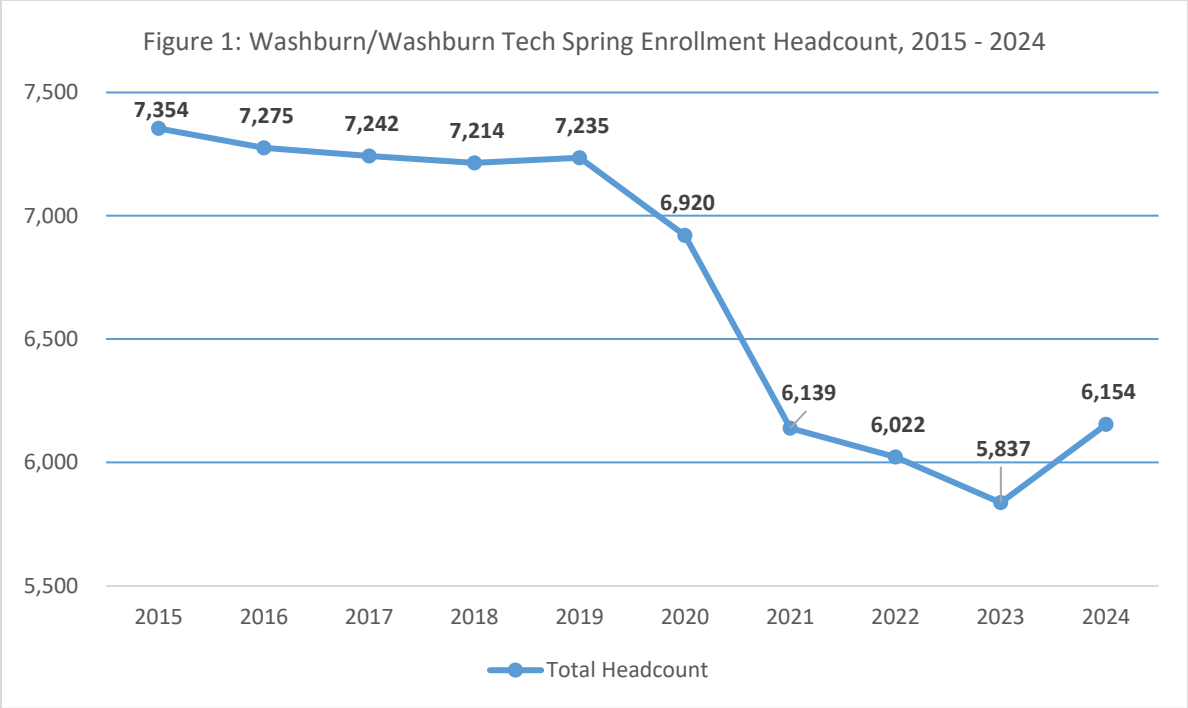
- Not Indicated was added as a new category for gender in Spring 2023.
- The proportion of Female students has increased over a ten-year trend, from 58.5% of the total student population in Spring 2015 to 63.2% in Spring 2024.

Washburn University Headcount by Student Classification and Full-time/Part-time Status (Table 7, page 12)

- Seniors and Freshmen comprise the largest percentage of full-time students in Spring 2024, at 23.4% and 22.9%, respectively.
- Seniors and Graduate students comprise the largest proportion of degree-seeking part-time students, with 18.5% and 15.4%, respectively.
- The ratio of full-time to part-time students by classification has trended more toward full-time (68.9%) than part-time (31.1%) during the last five-year period.

Washburn University Full-time Equivalent Enrollment by Student Classification (Table 8, page 13)

- FTE enrollment decreased for four years from 4,212 in Spring 2020 to 3,624 in Spring 2023, then increased to 3,880 in Spring 2024.



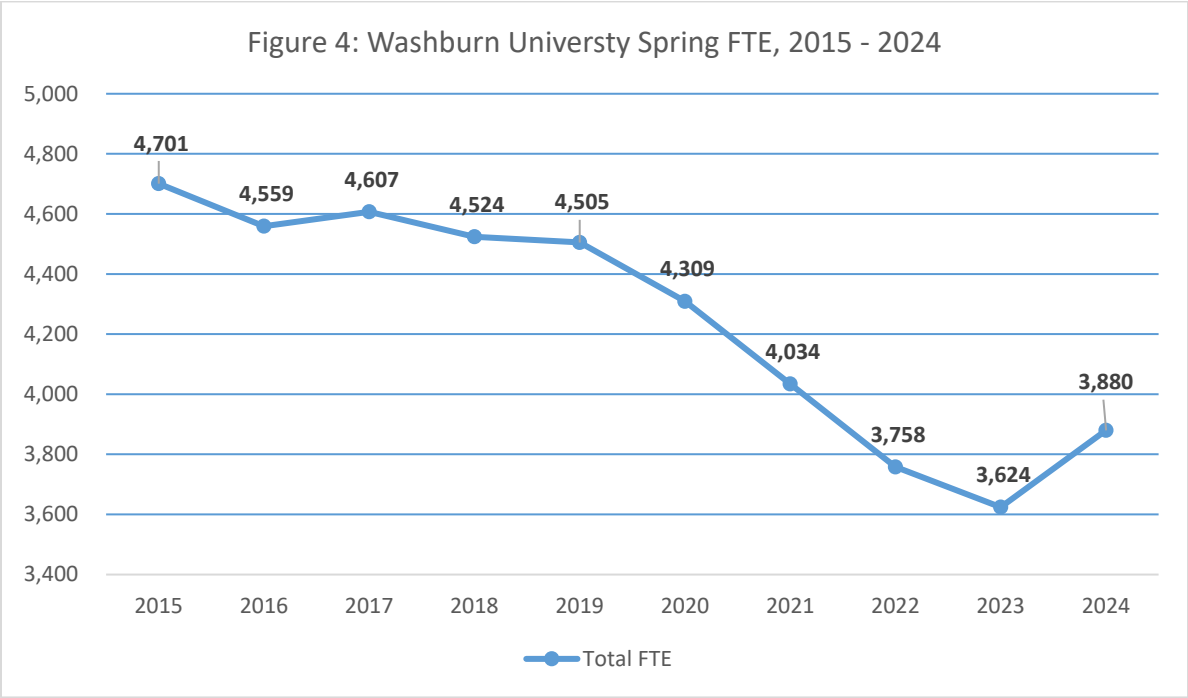
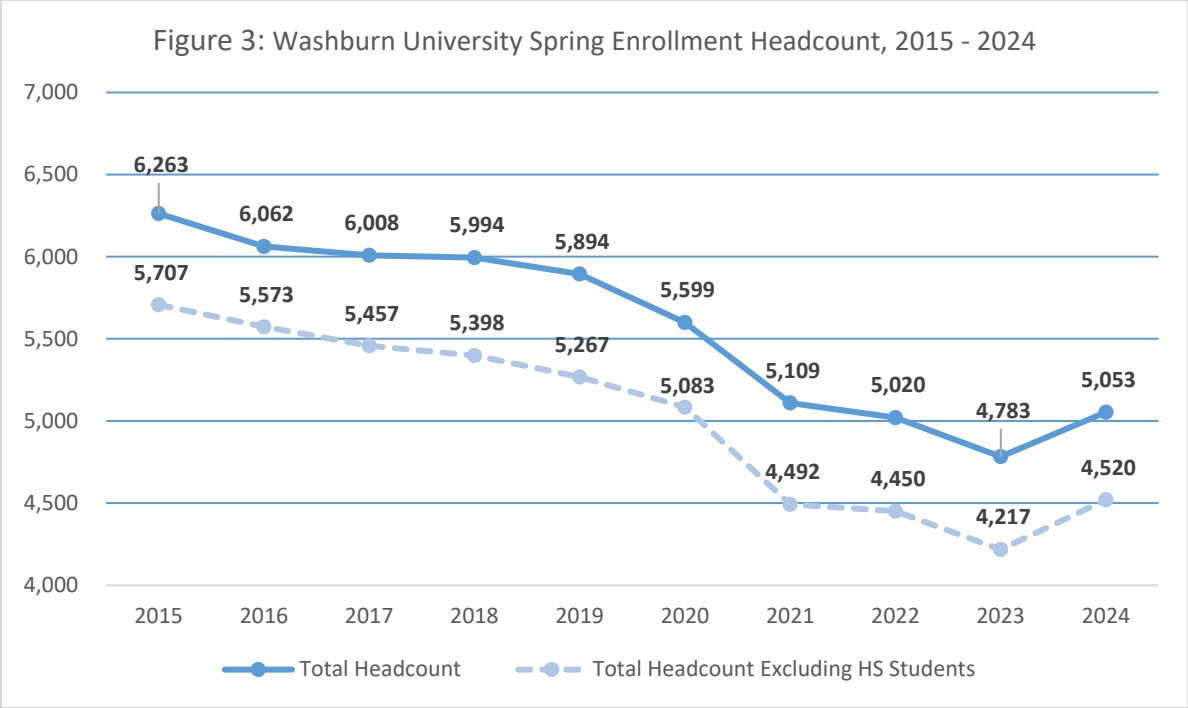

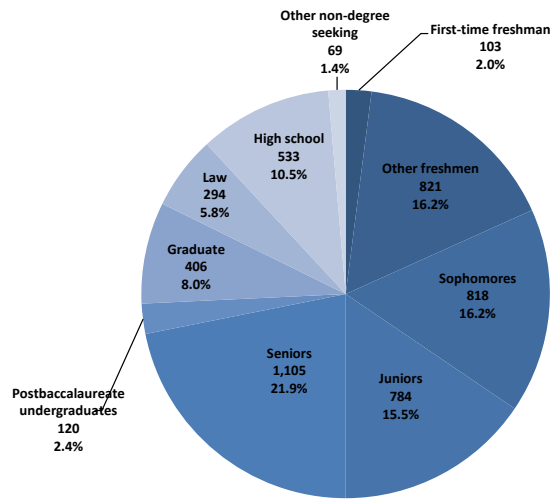

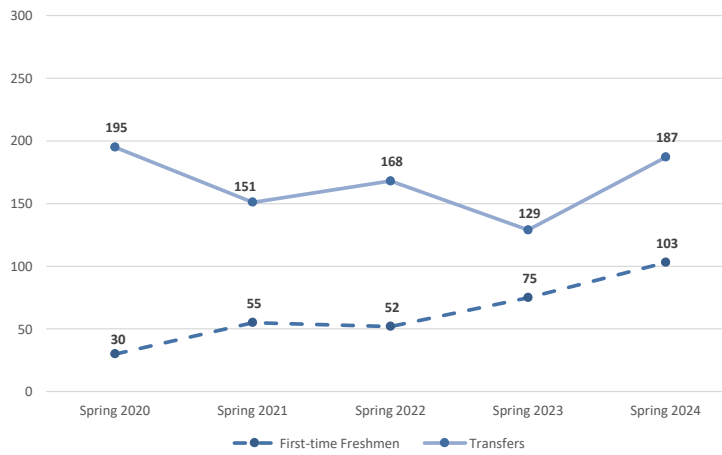

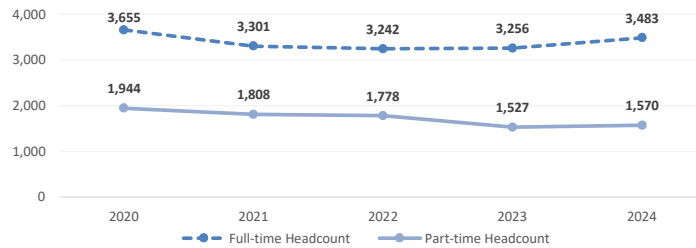
**Chart 1
