Overall Recommendations

The radiologic technology program will continue with the revised assessment plan and PSLOs.

Overall Reflection

The radiology assessment committee is composed of both radiologic technology faculty, as well as one radiology manager, and one allied health faculty.

The assessment report is presented to both the Clinical Preceptor Advisory Board and the Radiology Managers Advisory Board. The Washburn University assessment report has been realigned with the national accreditation assessment plan/report.

Faculty Collaboration

Faculty members meet at the end of each semester to gather applicable assessment data. The data is then analyzed not only by faculty but by a separate radiology assessment committee comprised of both full-time faculty, allied health faculty member, and a radiology manager.

Communication & Collaboration with Students

Before entering the course of study, interested students and applicants can access the mission statement, goals, and outcomes are stated on the program's public website.

Program mission and goals are listed in the majority of course syllabi and are discussed in the new student orientation in August.

One student representative is present at the Advisory Board during which the assessment report is reviewed

Communication & Collaboration with External Stakeholders

Students and external stakeholders are made aware of the PSLOs and measures through various modes. First, program outcomes and goals are stated clearly on the program's website, which is open to the public. The program's outcomes and goals include the PSLOs, but also include some other measures such as program effectiveness measures required by an accrediting body (Joint Review Committee on Education in Radiologic Technology).

The clinical preceptors' advisory board meets in the fall and the radiology management advisory board in the spring. At each meeting, the board reviews the programs outcomes and goals as well as the mission of the program. It is in the spring meeting when the assessment plan and annual data is provided and reviewed in significant detail as that is when the 6-month post-graduation data (graduate and employer surveys) is discussed from the previous graduating class.

Communication & Collaboration with University

The program director participated in the drop-in meetings hosted by the Assessment Team. Program assessment and reporting were discussed and suggestions made by the Assessment Team were implemented.
