### VIII. Discussion

- A. Updates from the Dean
  - 1. Hard work towards improving enrollment has paid off. Faculty effort is appreciated!!!
  - 2. State of the University speech discussed the importance of online courses and increasing online offerings. Requires thoughtful consideration (what makes sense). Varies by department. Psychology is fully online in sequence, but has limited choice. How do we support faculty in making shifts towards online courses? Should we be offering stipends for converting courses to an online format? CFC discussion included following comments:
    - a. Filming lectures is not an "online course"
    - b. Some faculty have Quality Matters (QM) training or are Colleague to Colleague (C2C) members. KCREACHE used currently at Washburn (not QM). Some students think online courses are less rigorous, lots of variability course to course. Students should be spending more time on online courses. Creating course shells can make it easier for instructors. Discussion boards help to create a learning community and often improve course participation.
    - c. School of Nursing uses QM (same template for all courses). Sue Taylor Owens has availability to help faculty convert content.
    - d. Very important to consider where online courses are appropriate. Science labs and programming classes can be difficult to convert to an online format.
    - e. Stipends could be a double-edged sword, faculty may create course simply for stipend.
  - 3. Faculty senate met this week. The Guns on Campus Policy was

presented (discussion at staff counsel meeting October 18<sup>th</sup> at 3 pm in Lincoln). There will be upcoming town meetings to discuss.

- 4. Board of Regents are considering a salary increase program, 1.8%. Budget cuts may affect the college.
- 5. Candidate Search
  - a. VPAT Search checking references on the short list
  - b. CIO candidates interviews have taken place
  - c. VPAA representatives from the college to the search committee have been elected.
- 6. STEM classroom will be funded by private donations; it will be located in the basement of Henderson; purpose of educating public school teachers in STEM education. Additionally, the Teaching Excellence in Science Prize has been funded for another 10 years.
- 7. A GoFundMe type platform is being instituted by WUF to fund small academic projects.
- 8. Ten course success groups have been created for the 2016-2017 school year.
- 9. We will be continuing the use of SIR-II this year.
- 10. Small lunches in the Dean's office will be held this year with the goal of connecting faculty from different departments; focus on new faculty, "match-making" to encourage collaboration
- 11. A training videos for admissions counselors will be created featuring ten departments. The departments were identified because they attract the most interest from incoming students.
- 12. CAS Distinguished lecturer On October 27<sup>th</sup> at 7 pm Bob Beatty will be presenting "American Shocker: Inside the Wild 2016 Presidential Election from Start to Finish"
- 13. Summer courses still attempting to find the right price threshold; it may be helpful to enroll in Summer courses when advising for Spring registration
- 14. Halloween party the morning of October 31 Chris Rhoads' famous cinnamon rolls will be available in the Dean's office from 8:30-11 (Get there early!)

- II. Minutes of the April 27, 2015 meeting were approved by email.
- III. Committee reports
  - a. Academic/Sweet Sabbatical Committee
    - Has not met
    - Applications are due at the beginning of November
  - b. Assessment Committee
    - Had a presenter for a couple of days to answer questions
    - Reviewed 12-14 assessment plans and program models from across the university
    - Will share information with departments
  - c. General Education
    - Has not met, but will meet next week
    - Six new courses sent forward
      - 1. One from each of the three general education areas
      - 2. Three 100 level honors courses
  - d. MLS one application reviewed, gave feedback to chair
  - e. Faculty senate
    - Discussed concealed carry weapons policy
    - Questions about faculty petition, but concealed carry is a law
  - f. Faculty handbook committee, plans to clean up language for clarity
  - g. Library
    - Funds are limited
    - Specific requests should be sent in by November 15

- V. Old business
  - a. Discussion: Updates to the B.Ed? RD 484 and ED 402?
    - Cherry Steffen explained the status of the program revisions
    - Handed out a draft of program; EDKN discussed this draft
    - Standards have changed, now using CAEP and InTASC standards
    - Rewriting framework, determined what needs to be on worksheet, got input from everyone
    - Had three meetings, can we be innovated and creative, one goal need to decrease hours but provide students with what they need

- Some pieces still missing, will share with EDKN and UTEC as it gets closer to the end of semester
- Shared framework in the spring of 2016 with division
- Technology discussion, introduction to technology course, then seminars relating technologies to disciplines, better integration for technology, discussion of badges and how they fit into technology standards
- Exceptional learners needs more discussion, can maybe meet this with different courses
- Diversity, maybe have social science develop a course, would like to replace cultural anthropology
- Reading 484 discussion
  - 1. looking more like integrating content, still looking at how to implement
  - 2. Roy Wohl suggested that there is information on how reading is implemented which can be reviewed, KN wants to keep focus on PE, KN wants students to integrate reading but not teach students to read
  - 3. Cherry Steffen noted that students need background to understand reading instruction
  - 4. Tiffany Dirks gave examples of how PE integrates reading in program
  - 5. EDKN will tentatively plan to have a meeting at the end of the semester to look at progress
- VI. New business No new business
  - a. Cherry Steffen FYI developing middle grade STEM program, will provide students to have a license in middle school math and/or science
  - b. Gloria Dye new program, Paraprofessional to Teacher program moving paras into teaching, most in special education with a couple in math, brought in trainer for co-teaching seminars, have monthly seminars for support along with a field-based mentor and university coach
