## **Overall Recommendations**

The students continue to excel in this program and usually take their certification exams quickly and begin employment immediately after. I would recommend doing some kind of student exit survey which has not been done before. Simply because this is a collaboration with another university as well as students travel and stay on campus in Nebraska for the summer session.

#### **Overall Reflection**

The UNMC program maintains external accreditation through the NAACLS (National Accrediting Agency for Clinical Laboratory Sciences) and overall assessment of the medical laboratory science curriculum is conducted on their campus.

#### **Faculty Collaboration**

The Washburn Program Coordinator and contacts at UNMC collaborate on clinical sites and proctoring of exams. The Washburn University Program Coordinator is responsible for enrolling students at Washburn University for the required MLS courses.

Outcomes and clinical problems are discussed at departmental Allied health meetings for recommendations.

#### **Communication & Collaboration with Students**

Assessment of student program retention rates, certification examination results and employment rates are shared with program applicants and program majors via information posted on the program's website. The Program coordinator usually proctors at least one exam a week and communicates with students in person



on going curriculum or any problems that arise.

## **Communication & Collaboration with External Stakeholders**

Program retention rates, certification examination rates, results and employment rates are shared with program applicants, program majors and advisory board members which include clinical sites and some employers.

Program data is also included in departmental annual reports submitted to the Dean and VPAA. Applicants are chosen by Washburn faculty and clinical instructors and then shared with UNMC Program Coordinator.

# **Communication & Collaboration with University**

Program coordinator attends C-Tel assessment events/workshops and meets with C-Tel assessment coordinator to learn best practices for program assessment.

Program data is also included in departmental annual reports submitted to the Dean and VPAA.
