WHEREAS: WSGA acknowledges and condemns the presence of systemic racism in our society; aware that it permeates virtually all institutions based on the legal and historical realities of the last four hundred years and the present day, and

WHEREAS: The purpose of this resolution is to introduce a mandated Diversity and Inclusion training for all administration, faculty, and staff, in order to ensure they are equipped with the tools to properly understand and distribute ways of conducting business, creating curriculum, and engaging in Diversity and Inclusion informed conversations, and

WHEREAS: If the administration, faculty, and staff are informed about Diversity and Inclusion, they can lead by example and demonstrate to students the importance of developing those skills so that they can establish them in the workforce after college, and

WHEREAS: Students who are informed and educated will increase their marketability and ability to work with diverse populations, and

WHEREAS: AmericanProgress.org suggests, "It is not surprising that by 2030, 54 percent of new workers will be people of color. Today, a majority of babies born in the United States are children of color", and

WHEREAS: Within three decades, America will have no clear racial or ethnic majority, and more than half of the population will be people of color. These changing demographics demonstrate the need for an agenda that prepares the workforce of the future economy.

THEREFORE, BE IT RESOLVED:

SECTION ONE: WSGA supports Diversity and Inclusion efforts and wants to see meaningful change to this institution on the basis of Diversity and Inclusion.

SECTION TWO: WSGA supports and recommends Washburn to invest in our diverse students with a high degree of cultural competence, empathy, and impact through Diversity and Inclusion training for all Washburn University employees.

TITLE: In Support of a College Diversity-Focused Required Course

ORIGINATOR: Diversity and Inclusion Committee

SPONSOR: Smith/Campa Administration

STATUS: Diversity and Inclusion Committee – Pending

WHEREAS: The U.S Department of Education states, “a growing body of research shows that diversity in schools and communities can be a powerful lever leading to positive outcomes in schools and in life... Today’s students need to be prepared to succeed with a more diverse and global workforce than ever before.”, and

WHEREAS: A diverse-focused course will allow student to learn from one another due to their different perspectives, and

WHEREAS: A diversity-focused course requirement is an important component of our commitment to expose students to beliefs and backgrounds other than their own, and

WHEREAS: Exposure to other beliefs and backgrounds will be beneficial to everyone since it will educate students on how elements-of-identity play a part in life, and

WHEREAS: The installment of a single Diversity-focused class requirement is to be consider as a stepping stone to further Washburn University’s commitment to Inclusion and not as a “solution.”

THEREFORE, BE IT RESOLVED:

SECTION ONE: WSGA supports that all students who wish to earn an undergraduate degree at Washburn University will be required by the university and/or their departments to complete a ‘diversity-focused’ course.

SECTION TWO: WSGA recommends the diversity-focused course shall focus on at least one of the following categories: one or more groups historically excluded on the basis of culture, race, ethnicity, gender, sexual orientation, class, disability, religion, age, immigration, or geopolitical power within or outside of the U.S.

SECTION THREE: The Academic Diversity and Inclusion Committee shall compare a list of course that fall under the “diversity-focused” course and be sent to departments to advise students.

SECTION FOUR: The Academic Diversity and Inclusion Committee shall audit the class every other year to be aware how diversity and inclusion is being taught.

SECTION FIVE: A copy of this resolution shall be sent to Vice President of Academic Affairs Dr. JuliAnn Mazachek, Faculty Senate President Dr. Kim Morse, Danielle Dempsey-Swopes in the Diversity and Inclusion Office, and the Academic Diversity and Inclusion Chair Dr. Kelly Erby.
