3. There's a seeming vendetta, federally, against higher education. Other institutions have threats to faculty, funding, and being undermined by the federal and state administrations.

SENATE BILL 2024-25 #165

TITLE: Student Activity Fee Modernization Act ORIGINATOR: Burdick/Wood Administration SPONSOR: Burdick/Wood Administration

STATUS: Student Activity Fee Review Committee – Favorable

WHEREAS: The Washburn University Board of Regents (WUBOR) has authorized Washburn University of Topeka to levy a student activity fee, which shall be used to provide an academic and cultural environment in which every student may attain the highest possible level of growth and development, and

WHEREAS: Washburn Student Government Association (WSGA) shall be the primary agency responsible for recommending the dollar amount of the student activity fee and shall consider present and future enrollment trends, as well as economic conditions such as wages and inflation, and

WHEREAS: WSGA is currently running a deficit, and has already made substantial cuts to many of its line items to attempt to correct its financial deficit, and

WHEREAS: Despite budget cuts WSGA is still running a deficit, putting significant strain on student services and endangering operations, and

WHEREAS: The current Student Activity Fee for the Fiscal Year 24-25 is \$58.50.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: All students enrolled in any credit hours at Washburn University will be charged a base Student Activity Fee of \$70.00 each semester.

SECTION TWO: Should WUBOR increase tuition by any percentage, the Student Activity Fee will increase by that same percentage, not to exceed 3%.

SECTION THREE: A copy of this legislation shall be presented to the WUBOR by the WSGA President and Vice President in May to approve this change.

SECTION FOUR: This legislation shall become effective upon passage and bearing the signature of the WSGA President and Vice President.
