- a. Topeka Metro Talk
 - i. Dr. Bearman is here to talk on his experience on the Topeka Metro Board. People said they have questions.
 - ii. What is Metro on Demand? Microtransit version of Uber or Lyft.
 - iii. How do they keep the metro safe? Firstly, under COVID, they had to think about the routes of the demographics they were targeting. Metro on Demand will find people and take them to bus stops and whatnot.
 - iv. 6-6 Hours on Topeka Metro are hindering to students. The ridership doesn't support it. They've also had the same budget for the last 8/9 years.
 - v. How can they get out the word that this is changing? They have pretty extensive hearings on how they spread the word.
 - vi. Data on how many people use it? It's been brought to WSGA
 - vii. They do have their own social media- yes they do
 - viii. Are there any safety measures? It's one of the safest places! We don't see very many issues.
 - ix. Dr. Bearman wouldn't vote no on increasing the bus schedule.
 - x. How do routes change? They are continually looking at ridership and running times to devise a route. A lot of these east-west ridership.

- xi. Would Topeka metro be available to partnering? It would be available.

- xiv. They have worked actively with Topeka Police Department, and are continuing to keep an eye on it. We're not in a big city, so it's not as big of a deal. They have been looking at security on the bus system. There are cameras on the bus. They are federally funded.

- xvii. The fee hasn't been raised in a long time. Is there any plan? The board has been clear in in their fares.
- xviii. Are we able to analyze the route? They do already track the route. Have they looked into routes that are near grocery stores? It's just the economics of the situation, and they do unfortunately have to reduce services. They have a struggle to get operators to run the system
 - xix. What are the benefits and pay for drivers? \$25 an hour (goes up with experience). The average age of operators is 52. If he was young he wouldn't want a job that goes from 6-6.
 - xx. Goals and plans for the next 5-10 years? Keep metro on the streets. Wake up everyday and hope for federal funding. Bring some electric busses. But he doesn't know if he can count on 5-10 years, it's scary. They've had some losses.

Cheer/Dance:

Budget is broken down in two ways

Cheer/Mascot: \$18,000 (they are looking to increase Cheer/Mascot to \$25,600) + \$5,558 = \$23,558

Dancing Blues: \$12,000 + 1,515 = \$13,515 (looking to increase to 14,400)

They are asking for more funding. They are needing some carts and five gallon jugs of water, and there is no where to really get those. They need mat movers. They are looking for \$800 a student.

They are looking to improve the Bod Squad.

WSGA's funding goes to transportation, hotels, dues/memberships, clothing and mascots, signs, palms, megaphones, etc.

New branding has also made it a bit difficult- need new backpacks for example.

Campus Activity Board:

Does CAB allocate funding for their events?

Within their report they start with 35,000 - and it has gradually gotten down to around 20,000.

A few components need updated: currency, amount in attendance, and when these events take place.

They're trying to keep some reoccurring events, just to keep the name alive. They kind of do need to, however, revitalize some things. Collaborating with more organizations might be helpful. Lego competition should be at the end of the month.

Student Media:

Salaries, training, technology, printing, office supplies, staff incentives (free food!), cameras, media memberships, media tools, office telephones, promotions, student initiatives.

Hire about 50-65 students for social media.

The relationship between Mass Media and Student Media is strong, but they are within two separate departments.

There is about \$80,000 extra, and we are wondering where that extra money might go.

How often do cameras need to be purchased or office sofas/computers.

They don't purchase new stuff too often, but there are occasional purchases, especially with this last year given new staff members.

Context on the yearbook:

They put so much money into the yearbook, but there wasn't as much interactivity or retention.

Student Media is trying to retain some members through giving stories that people find fun.
